Definition:	<p>An indicator of permanent blindness. An individual is permanently blind if:</p> <ul style="list-style-type: none"><li>• visual acuity on the Snellen Scale after correction by suitable lenses is less than 6/60 in both eyes;</li><li>• a field of vision constricted to 10 degrees or less of arc around central fixation in the better eye irrespective of corrected visual acuity (equivalent to 1/100 white test object);</li><li>• a combination of visual defects resulting in the same degree of visual impairment as that occurring in the above points.</li></ul>
