This will include private patients treated in public hospitals, and may include public patients treated in private hospitals.			
	From 2016–17 onwards, this NMDS amalgamates the previously separate Elective surgery waiting times (census data) NMDS and Elective surgery waiting times (removals data) NMDS.			
	Data are collected for patients on elective surgery waiting lists who are yet to be admitted to hospital and for patients who have been removed from an elective surgery waiting list (for admission or another reason).			
	Patients are included regardless of their readiness for care, as defined in the <u>Elective surgery waiting list episode—patient listing status, readiness for surgery</u> <u>code N</u> data element.			
	Hospitals may also collect information for other care (as defined in the 'waiting list category' data element), but this is not part of the NMDS.			
	Patients on, or removed from, elective surgery waiting lists managed by hospitals operated by the Australian Defence Force, corrections authorities and Australia's external territories are not included.
