o h	A notification consists of reports made to an authorised department by persons or other bodies making allegations of child abuse or neglect, child maltreatment or narm to a child. Notifications should not include reports regarding wider concerns about children or families which are classified as child concern reports.
u	Notifications are relevant to persons who are aged less than 18 years, and to unborn children in jurisdictions where they are covered under the child protection egislation.
p s h	An investigation is the process whereby the Department responsible for child protection seeks to obtain more detailed information about a child who is the subject of a notification and makes an assessment about the harm or degree of narm to the child and their protective needs. An investigation includes the nterviewing or sighting of the subject child where it is practicable to do so.
c n s	A finalised investigation is classified as 'substantiated' where there is reasonable cause to believe that the child has been, is being or is likely to be abused or neglected or otherwise harmed. Substantiation does not necessarily require sufficient evidence for a successful prosecution and does not imply that treatment or case management was, or is to be, provided.
e h ty c	Substantiations are classified into four categories: physical abuse, sexual abuse, emotional abuse and neglect. Where more than one type of abuse or neglect or narm has occurred, the primary type of abuse/neglect should be classified to the ype most likely to be the most severe in the short term or most likely to place the child at risk in the short term, or if such an assessment is not possible, to the most obvious form of abuse or neglect.
b s tt n tt tt p	A notification can only involve one child. Where it is claimed that two children have been, or are at risk of being abused, neglected or harmed, this is counted as two separate notifications, even if the children are from one family. Where there is more han one notification about the same 'event', this should be counted as only one notification and appear as a single line in the file for each child indicated. Where here is more than one notification for a child within the reference period but relating o different events (for instance, a different type of abuse or neglect or a different berson believed responsible), these should be counted as separate notifications and appear as a new line in the file.
