Guide for use:	The commencement date is the date on which an admitted palliative care patient commences a new palliative care phase type. Subsequent phase start dates are equal to the previous phase end date.
Collection methods:	The palliative care phase start date is to be recorded at the commencement of the episode of admitted patient palliative care and at the commencement of every subsequent palliative care phase thereafter in the same admitted patient episode.
