Guide for use:	<p>The rules for calculating the number of hospital-in-the-home days are outlined below:</p> <ul style="list-style-type: none">• The number of hospital-in-the-home days is calculated with reference to the date of admission, date of separation, leave days and any date(s) of change between hospital and home accommodation;• The date of admission is counted if the patient was at home at the end of the day;• The date of change between hospital and home accommodation is counted if the patient was at home at the end of the day;• The date of separation is not counted, even if the patient was at home at the end of the day;• The normal rules for calculation of patient days apply, for example in relation to leave and same day patients.
