These measures are reported for children and young people aged less than 18 years whose care arrangements were ordered through the Children's Court, where parental responsibility for the child or young person was transferred to the Minister/Chief Executive. The scope for the National Out-of-Home Care Standards includes children and young people who were residing in out-of-home care arrangements, Specialist Homelessness Services, disability facilities, juvenile detention, were self-placed or homeless. |
