Guide for use: This data element should be used in conjunction with the data elements: [Person—alcohol consumption frequency, AUDIT frequency alcohol consumption code N](#) and [Person—alcohol consumption amount, total standard drinks N\[N\]](#) to obtain a score on the Alcohol Use Disorders Identification Test (AUDIT) and consequently obtain a risk of alcohol-related harm.

Comments: The AUDIT is an alcohol screen that can help identify patients who are hazardous drinkers or have active alcohol use disorders (including alcohol abuse or dependence).

The Prisoner Health Information Group amended the question wording for the National Prisoner Health Census to 'Prior to your current incarceration, how often did you have six or more standard drinks on one occasion?'
