<b>Guide for use:</b>	<p>Each separately administered health care establishment is to have a unique identifier at the national level.</p> <p>Concatenation of:</p> <p>Australian state/territory identifier (character position 1);</p> <p>Sector (character position 2);</p> <p>Region identifier (character positions 3-4); and</p> <p>Organisation identifier (state/territory) (character positions 5-9), or Specialised mental health service organisation - organisation identifier (character positions 5-9). Specialised mental health service organisation identifiers should be prefaced with a 0.</p> <p>Where services are provided by non-government organisations contracted through a jurisdictional health department, the identifier should be reported as the state/territory identifier for the jurisdictional health department, and blank filled with the character 7 (e.g. 47777777 SA Health department, contracting non-government organisation services).</p>
<b>Comments:</b>	<p>Establishment identifier should be able to distinguish between all health care establishments nationally. This data element differs from the previous data element <a href="#">Establishment—organisation identifier (Australian)</a>, NNX[X]NNNNN in that the <a href="#">Specialised mental health service organisation—organisation identifier</a>, XXXX are now included in the concatenation.</p>
