<b>Rationale:</b>	<p>The evidence for screening well people for asymptomatic disease is well established for a specified number of conditions. Screening detects the disease at an earlier stage, and this allows good clinical management with the aim of reducing and preventing complications. Health assessments indicate quality of primary health care services, with a focus on health promotion and prevention.</p>

It includes MBS-rebated Indigenous health assessments (MBS items: 715; 228; 92004; 92016; 92011; or 92023).</p> <p>For ages 0–14: an Indigenous health assessment is counted if it was completed within the previous 12 months.</p> <p>For ages 15+: an Indigenous health assessment is counted if it was completed within the previous 24 months.</p>
