It does not refer to arrangements where the carer worker only received reimbursements of expenses or occasional sitting fees for attendance at meetings.</p> <p>Mental health carer workers employed at the jurisdictional or regional level are considered in-scope. Salary costs should be apportioned between all establishments, as deemed appropriate by the jurisdiction (full-time-equivalent staff figures should be apportioned on the same basis).</p>
Collection methods:	<p>Note: This code is only to be reported for the Mental Health Establishments NMDS.</p> <p>For Local Hospital Networks/Public hospital establishments NMDS data are to be reported in a category according to specific state and territory arrangements.</p>
