	A general practitioner (GP) is a doctor who is also qualified in general medical practice.
	CODE 02    Neurologist
	A neurologist is a specialist physician who diagnoses and treats conditions of the brain, spinal cord and nerves.
	CODE 03    Geriatrician
	A geriatrician is a specialist doctor who cares for people aged 65 and over. Most are experts at helping people who have multiple conditions.
	CODE 04    Old age psychiatrist
	An old age psychiatrist is a psychiatric subspecialty focusing on the mental health of older persons.
	CODE 05    Neuropsychologist
	A neuropsychologist is a psychologist who specialises in understanding the relationship between the physical brain and behaviour.
	CODE 06    Psychiatrist
	A psychiatrist is a physician who specialises in psychiatry, the branch of medicine devoted to the diagnosis, prevention, study, and treatment of mental disorders.
