<b>Rationale:</b>	Smoking has been identified as one of the key risk factors contributing to the burden of disease for Indigenous Australians. It is important that Indigenous primary health-care organisation know the smoking status of clients in order to provide appropriate medical care.

<b>Computation description:</b>	<p>Proportion of <a href="#">Indigenous regular clients</a>, aged 15 and over whose smoking status has been recorded within the previous 24 months at the primary health care organisation.</p> <p>Presented as a percentage.</p> <p>Results arising from measurements conducted outside of the organisation, that are known by the organisation, are included in the calculation of this indicator.</p> <p>Operationalisation of smoking status:</p> <p>Where an Indigenous regular client's tobacco smoking status does not have an assessment date assigned within the Clinical Information System (CIS), smoking status as recorded in the CIS should be treated as current (i.e. as having been updated within the previous 24 months).</p>
<b>Computation:</b>	$(\text{Numerator} \div \text{Denominator}) \times 100$
<b>Numerator:</b>	Number of Indigenous regular clients, aged 15 and over whose smoking status has been recorded within the previous 24 months at the primary health care organisation.
