Description:	<p>Proportion of Indigenous regular clients aged 15 and over whose smoking status has been recorded within the previous 24 months as one of the following:</p> <ul style="list-style-type: none">• current smoker• ex-smoker or• never smoked.
Rationale:	<p>Smoking has been identified as one of the key risk factors contributing to the burden of disease for Indigenous Australians. It is important that Indigenous primary health-care organisation know the smoking status of clients in order to provide appropriate medical care.</p>

Collection and usage attributes

Computation description:	<p>Proportion of Indigenous regular clients aged 15 and over whose smoking status has been recorded within the previous 24 months as one of the following:</p> <ul style="list-style-type: none">• current smoker• ex-smoker or• never smoked. <p>Presented as a percentage.</p> <p>Operationalisation of smoking status:</p> <p>Where an Indigenous regular client's tobacco smoking status does not have an assessment date assigned within the Clinical Information System (CIS), smoking status as recorded in the CIS should be treated as current (i.e. as having been updated within the previous 24 months).</p> <p>Calculated separately for each smoking status.</p>
Computation:	$(\text{Numerator} \div \text{Denominator}) \times 100$

Numerator:

Calculation A: Number of Indigenous regular clients aged 15 and over whose smoking status has been recorded as 'current smoker' within the previous 24 months.

Calculation B: Number of Indigenous regular clients aged 15 and over whose smoking status has been recorded as 'ex-smoker' within the previous 24 months.

Calculation C: Number of Indigenous regular clients aged 15 and over whose smoking status has been recorded as 'never smoked' within the previous 24 months.
