Description:	Proportion of Indigenous regular clients aged 11 and over whose smoking status result recorded within the previous 24 months was: • current smoker; • ex-smoker; or • never smoked.
Rationale:	Smoking has been identified as one of the key risk factors contributing to the burden of disease for Indigenous Australians. It is important that Indigenous primary health-care organisation know the smoking status of clients in order to provide appropriate medical care.

Collection and usage attributes

Population group age from:	11 years and over.
Computation description:	Proportion of Indigenous regular clients aged 11 and over whose smoking status result recorded within the previous 24 months was: • current smoker; • ex-smoker; or • never smoked. Presented as a percentage. Calculated separately for each smoking status. Operationalisation of smoking status: where an Indigenous regular client's tobacco smoking status does not have an assessment date assigned within the Clinical Information System (CIS), smoking status as recorded in the CIS should be treated as current (i.e. as having been updated within the previous 24 months). Include: results arising from measurements conducted outside of the organisation that are known by the organisation.

Numerator:

Calculation A: Number of Indigenous regular clients aged 11 and over whose smoking status result was recorded as 'current smoker' within the previous 24 months.

Calculation B: Number of Indigenous regular clients aged 11 and over whose smoking status result was recorded as 'ex-smoker' within the previous 24 months.

Calculation C: Number of Indigenous regular clients aged 11 and over whose smoking status result was recorded as 'never smoked' within the previous 24 months.
