Rationale:	Smoking has been identified as one of the key risk factors contributing to the burden of disease for Indigenous Australians. It is important that Indigenous primary health-care organisation know the smoking status of clients in order to provide appropriate medical care.

Collection and usage attributes

Population group age from:	11 years and over.
Computation description:	Proportion of Indigenous regular clients , aged 11 and over whose smoking status was recorded within the previous 24 months. Presented as a percentage. Operationalisation of smoking status: where an Indigenous regular client's tobacco smoking status does not have an assessment date assigned within the Clinical Information System (CIS), smoking status as recorded in the CIS should be treated as current (i.e. as having been updated within the previous 24 months). Include: results arising from measurements conducted outside of the organisation that are known by the organisation.
