<b>Guide for use:</b>	<p>CODE 1 Yes</p> <p>Record if the child is enrolled in an early childhood education program for their second or third year, i.e. the child is repeating the early childhood education program intended for children in the year before they commence full-time schooling.</p> <p>CODE 2 No</p> <p>Record if the child was not enrolled in an early childhood education program for their second or third year, i.e. this is the first year the child has been enrolled in an early childhood education program intended for children in the year before they commence full-time schooling.</p> <p>CODE 3 Unknown</p> <p>Record if it cannot be determined whether the child is enrolled in their second or third year of an early childhood education program intended for children in the year before they commence full-time schooling.</p>
<b>Collection methods:</b>	Repeat enrolments are to be identified at a jurisdictional level. This will enable the identification of second year enrolments across service providers.
