<b>Computation description:</b>	<p>Every stillbirth should be reviewed locally as part of a formal perinatal mortality audit process.</p> <p>The process should be carried out in line with the recommendations in the <i>Clinical Practice Guideline for Care Around Stillbirth and Neonatal Death</i>.</p> <p>To be included in the numerator the review process must:</p> <ul style="list-style-type: none"><li>• Use the PSANZ Classification System for Stillbirths and Neonatal Deaths to assign a cause of death, and any associated conditions and contributing factors related to care for all stillbirths, and</li><li>• Include an assessment of factors, including aspects of the woman's clinical care, that may have contributed to the baby's death using a relevant audit tool such as the Australian Perinatal Mortality Clinical Audit Tool.</li></ul> <p>Presented as a percentage.</p>
<b>Computation:</b>	$(\text{Numerator} \div \text{Denominator}) \times 100$
<b>Numerator:</b>	The number of stillbirths reviewed by the health service to identify any potential contributing factors and classified using the PSANZ Perinatal Death Classification.
<b>Denominator:</b>	The number of stillbirths.
