

is 'yes' the prisoner is asked:

• Was the qualification started, finished or unknown in prison?

• The type of qualification studied secondary schooling, certificate I, certificate II, certificate III, certificate IV, Diploma, Bachelor Degree, Postgraduate

qualification.

**Collection methods:** Information on the level of study undertaken by a prison dischargee whilst in prison

is collected on the National Prisoner Health Data Collection Prison Discharge form.
