If the response is 'yes' the prisoner is asked:</p> <ul style="list-style-type: none"><li>• Was the qualification started, finished or unknown in prison?</li><li>• The type of qualification studied secondary schooling, certificate I, certificate II, certificate III, certificate IV, Diploma, Bachelor Degree, Postgraduate qualification.</li></ul>
<b>Collection methods:</b>	Information on the level of study undertaken by a prison dischargee whilst in prison is collected on the National Prisoner Health Data Collection Prison Discharge form.
