Scope: The scope of the Sentinel event national best endeavours data set (SE NBEDS) is

to collect data about <u>sentinel events</u> experienced by patients in government health establishments. A sentinel event is an incident that is **wholly preventable** and has

caused serious harm to, or the death of, a patient.

To be classified a sentinel event, strict criteria need to be met:

The event should not have occurred where preventive barriers are available

- · The event is easily recognised and clearly defined
- There is evidence the event has occurred.

Sentinel events are further specified into eight events:

- Surgery or other invasive procedure performed on the wrong site resulting in serious harm or death
- 2. Surgery or other invasive procedure performed on the wrong patient resulting in serious harm or death
- 3. Wrong surgical or other invasive procedure performed on a patient resulting in serious harm or death
- 4. Unintended retention of a foreign object in a patient after surgery or other invasive procedure resulting in serious harm or death
- 5. Haemolytic blood transfusion reaction resulting from ABO incompatibility resulting in serious harm or death
- Suspected suicide of a patient in an acute psychiatric unit or acute psychiatric ward
- 7. Medication error resulting in serious harm or death
- 8. Use of physical or mechanical restraint resulting in serious harm or death
- 9. Discharge or release of an infant or child to an unauthorised person.
- Use of an incorrectly positioned oro- or naso- gastric tube resulting in serious harm or death.

The list of specified events corresponds to what is listed in the Productivity Commission's *Report on Government Services* (RoGS) (PC 2022)

The SE NBEDS supports the collection of data for the indicator *Australian Health Performance Framework: PI 2.2.3—Sentinel events*.

Collection and usage attributes

Statistical unit: A government health <u>establishment</u>.

Guide for use: The SE NBEDS comprises two principal data elements that, in combination,

describe the total number and types of sentinel events occurring in a government health establishment. They are collected together and reported as the number of sentinel events occurring during the collection period against each reported type of

event.

A third data element reports on the State/Territory to which the data relates.

Collection methods: National reporting requirements

State and territory health authorities provide the data to the Australian Institute of

Health and Welfare for national collation, on an annual basis.

The collection of sentinel events data is the responsibility of the health authorities in each of the states and territories. Public reporting against the sentinel events list is included in the Productivity Commission's *Report on Government Services* (RoGS) (PC 2022) as the total number of occurrences of each sentinel event by

jurisdiction.

All counts of sentinel events are published at the national, and state and territory level, with the exception of ACT (where the number of events is small and publishing this information might risk exposing the identities of persons involved).

The period for which data are collected and nationally collated is financial years

ending 30 June each year.
