Rationale:	Smoking has been identified as one of the key risk factors contributing to the burden of disease for Indigenous Australians. It is important that Indigenous primary health-care organisations know the smoking status of clients in order to provide appropriate medical care.

Calculation A: Number of Indigenous regular clients aged 11 and over whose smoking status result was recorded as 'current smoker' within the previous 24 months.

Calculation B: Number of Indigenous regular clients aged 11 and over whose smoking status result was recorded as 'ex-smoker' within the previous 24 months.

Calculation C: Number of Indigenous regular clients aged 11 and over whose smoking status result was recorded as 'never smoked' within the previous 24 months.
