Description:	<p>Proportion of female Indigenous regular clients who gave birth within the previous 12 months, and whose smoking status result recorded during pregnancy was:</p> <ul style="list-style-type: none">• current smoker;• ex-smoker; or• never smoked.
Rationale:	<p>Smoking during pregnancy is a risk factor for adverse events in pregnancy, and can be associated with low birthweight, pre-term birth, fetal growth restriction, congenital abnormalities and perinatal death. Low birthweight infants are at a greater risk of dying during the first year of life and are prone to ill health in childhood. Smoking during pregnancy is also associated with increased risk of spontaneous abortion and ectopic pregnancy.</p>

Where an Indigenous regular client's tobacco smoking status does not have an assessment date assigned within the Client Information System (CIS), smoking status should not be counted.</p> <p>Include: results arising from measurements conducted outside of the organisation that are known by the organisation.</p>
