	In such cases, the hospital where the outsourced or contracted elective surgery occurs is required to include the <u>Establishment—organisation identifier</u> ( <u>Australian</u> ), <u>NNX[X]NNNN</u> data element for the hospital managing the elective surgery waiting list as part of the Elective surgery waiting times data cluster.
